RESOLUTION NO. 5 for 1997

BOROUGH OF CHARLEROI POLICE PENSION PLAN (as amended and restated, effective January 1, 1987)

A RESOLUTION OF THE BOROUGH OF CHARLEROI RELATIVE TO THE ESTABLISHMENT AND MAINTENANCE OF BOROUGH EMPLOYEES PENSION, ANNUITY, INSURANCE AND BENEFIT FUND OR FUNDS, TO AMEND CERTAIN PROVISIONS OF THE PENSION PLAN OR PROGRAM APPLICABLE TO THE POLICE OF SAID BOROUGH.

WHEREAS, the Borough of Charleroi (the "Borough") has previously enacted an Ordinance establishing the Borough of Charleroi Police Pension Plan (the "Plan"); and

WHEREAS, the Plan was totally amended and restated, effective January 1, 1987; and

WHEREAS, the Employer reserved the right to amend the Plan pursuant to Section 10.01; and

WHEREAS, the Employer now desires the Plan to be further amended to provide a costof-living increase for certain retired participants;

BE IT RESOLVED AND ADOPTED by the Borough Council of the Borough and it is HEREBY RESOLVED AND ADOPTED by authority of the same:

Effective January 1, 1996, the Plan is amended by adding a new Section 5.08 as follows:

Cost-of-Living Adjustment - Each Participant who shall have retired and commenced 5.08 receipt of the payment of a retirement benefit under Section 5.02 of the plan prior to January 1, 1996, shall be entitled to receive a cost-of-living adjustment to the amount of benefit being paid to the Participant as of January 1, 1996, not including any Service Increment Benefit under Section 5.03. Such cost-of-living adjustment shall be a monthly amount equal to the amount of the cost-of-living adjustment being paid under the provisions of Act 147 which will be offset by this cost-of-living adjustment plus fifty dollars (\$50.00) payable for each month in which a retirement benefit is paid under the Plan on or after January 1, 1996. No cost-of-living adjustment shall ever exceed any of the following limits: (1) the percentage increase in the consumer price index for Urban Wage Earners and Clerical Workers (CP1-W) for the year in which the Participant was last employed as an employee of the employer; (2) the total retirement benefits payable under the Plan shall not exceed seventy-five percent (75%) of the Participant's Final Monthly Average Salary; (3) the total cost-of-living increase shall not exceed thirty percent (30%) of the Participant's Retirement Benefit under the Plan; and (4) the Cost-of-Living Adjustment shall not impair the actuarial soundness of the Plan.

Resolution of the Borough of Charleroi authorizing the filing of a proposal for funds with the Department of Community and Economic Development, Commonwealth of Pennsylvania.
