A RESOLUTION OF THE BOROUGH OF CHARLEROI, WASHINGTON COUNTY, PENNSYLVANIA, PROVIDING FOR THE ADOPTION OF A THREE (3) YEAR AGREEMENT FOR CHARLEROI BOROUGH THROUGH ITS POLICE DEPARTMENT TO PROVIDE POLICE PROTECTION FOR THE BOROUGH OF SPEERS AT A COST OF ONE HUNDRED THOUSAND AND 00/100 DOLLARS (\$100,000.00) PER YEAR, PLUS TWENTY PERCENT (20%) OF THE ACTUAL CHARLEROI BOROUGH POLICE COST OVER THE BASE YEAR 2004.

**BE IT RESOLVED,** by Council of the BOROUGH OF CHARLEROI, Washington County, Pennsylvania, as follows:

1. That the President of Council be and is authorized to execute, on behalf of the BOROUGH OF CHARLEROI, an agreement providing for the BOROUGH OF CHARLEROI, through its Police Department, to provide police protection for the BOROUGH OF SPEERS for a period of three (3) years commencing January 1, 2006 for an annual fee of \$100,000.00 for the first year, payable at the rate of \$8,333.33 per month; \$100,000.00 for the second year, payable at the rate of \$8,333.33 per month. In addition to the monthly payment, an annual payment of the sum equal to twenty percent (20%) of the increase in actual police cost incurred by the BOROUGH OF CHARLEROI over the base year of 2004; however, in no event shall such annual payment exceed the sum of \$1,200.00. Further providing that the minimum police force shall consist of eight (8) members, including the Superintendent. This Agreement shall be as more specifically set forth in the form attached hereto.

A RESOLUTION OF THE BOROUGH OF CHARLEROI, WASHINGTON COUNTY, PENNSYLVANIA, PURSUANT TO 53 P.S. § 46121 OF THE BOROUGH CODE, FIXING THE TOTAL WEEKLY HOURS OF EMPLOYMENT THAT SHALL APPLY TO POLICEMEN PERFORMING DUTIES ON BEHALF OF THE BOROUGH OF CHARLEROI.

BE IT RESOLVED, by Council of the Borough of Charleroi, Washington County, Pennsylvania as follows:

- 1. That the total weekly hours of employment for individuals appointed by Council to serve as policemen shall be as follows:
- (a) 240 hours per week for full-time officers and the Superintendent of Police, excepting as circumstances set forth in subsection (c) below;
- (b) 120 hours per week for part-time officers, excepting circumstances as set forth in subsections (c) and (d) below;
- (c) In the event either the Superintendent or any full-time officer properly exercises his or her right to the use of vacation and/or sick days or is otherwise unavailable to work a scheduled shift, the amount of full-time officer and Superintendent hours as set forth in subsection (a) above may be reduced from 240 hours and part-time officers may be utilized to staff the open shifts;
- (d) In the event part-time officers are needed to perform a special detail, the Mayor and Superintendent prior to scheduling the detail shall first obtain approval from the Chairman of Council's Police Committee;
- (e) Weekly scheduling of part-time officers to fulfill duties as set forth in subsections (c) and (d) shall be conducted in a fashion so as not to exceed a total of 1,760 hours per year;

(f) All scheduling of the Superintendent, full-time officers and part-time officers shall be reasonably calculated to comply with the requirements as set forth in this Resolution. Any departure which occurs or can be reasonably anticipated to occur from the requirements of this Resolution shall require the further approval of Council.

The required bond will be in an amount no less than \$190,000.00
