A RESOLUTION OF THE BOROUGH OF CHARLEROI, COUNTY OF WASHINGTON, COMMONWEALTH OF PENNSYLVANIA, ELIMINATING MEMBERS' CONTRIBUTIONS INTO THE POLICE PENSION PLAN FOR THE YEAR 2012.

WHEREAS, the Borough reserves the right to reduce or eliminate Participant Contributions on an annual basis below the mandated rate of five percent (5%) of compensation; and

WHEREAS, Act 600 further provides that Participant Contributions into the Charleroi Borough Police Pension Plan by Participants may be reduced or eliminated; and

WHEREAS, a Resolution is required to reduce or eliminate Participant Contributions on an annual basis; and

WHEREAS, the consultant for the Police Pension Plan of the Borough of Charleroi, as evidenced by the most recent Act 205 Actuarial Valuation Report and minimum municipal obligation, has determined that if Participant Contributions to the Police Pension Plan are eliminated, the Borough of Charleroi Police Pension Plan will not require additional contributions by the Borough, this determination is further based on assumption that state pension aid will be sufficient to cover the plan's funding requirements;

NOW, THEREFORE, BE IT RESOLVED and it is hereby resolved by the Borough Council of the Borough of Charleroi that effective January 1, 2012 and continuing through and including December 31, 2012, the amount of Participant Contributions due shall be zero percent (0%) of compensation. The obligation to pay Participant Contributions pursuant to Act 600 shall resume effective January 1, 2013.

RESOLUTION NO. 8

RESOLUTION ACCEPTING RECOMMENDATION OF A PHASE II JOINT POLICE STUDY COMMISSION TO CREATE A REGIONAL POLICE DEPARTMENT BETWEEN THE BOROUGHS OF CHARLEROI, NORTH CHARLEROI AND SPEERS AND TO APPOINT A PHASE III IMPLEMENTATION STUDY COMMITTEE FOR SAID PURPOSE

WHEREAS, the Council of the Borough of Charleroi previously appointed representatives to a Phase II Joint Study Committee with representatives of North Charleroi Borough and Speers Borough to consider the feasibility of alternative police protection services and that the committee has recommended the creation of a Regional Police Department to serve the three municipalities; and

WHEREAS, the Borough of Charleroi is authorized to establish a Phase III Joint Implementation Phase III Study Committee with Speers Borough and North Charleroi Borough for the purpose of implementing and taking steps to create a Regional Police Department under §5 of Article IX of the Pennsylvania Constitution, the Inter-governmental Cooperation Act 180, now a part of Pennsylvania Consolidated Statutes, Title 53, §§ 2301 through 2315

NOW, THEREFORE, BE IT RESOLVED:

- 1. The Borough of Charleroi does hereby accept the recommendation of the Phase II Joint Police Study Committee to create a Regional Police Department with Charleroi, North Charleroi Borough and Speers Borough;
- 2. The Borough of Charleroi does hereby appoint three representatives to a Phase III Implementation Study Committee for the purpose of doing all things necessary to create and establish a Regional Police Department.
- 3. The representatives appointed to the Phase III Implementation Study Committee shall be the Mayor, the President of Council and the Borough Manager. Council of the Borough of Charleroi further directs that the Solicitor participate in all Phase III meetings and assist the Phase III Implementation Study Committee in its work to establish a Regional Police Department.
- 4. The Borough of Charleroi hereby establishes the "PHASE III JOINT IMPLEMENTATION STUDY COMMITTEE" consisting of three representatives from each of the following participating municipalities: Charleroi Borough, North Charleroi and Speers Borough.
- 5. The role of the Phase III Study Committee shall be to carry on the completed study and work of the previously established Phase II Joint Police Study Committee and to:
- a. develop a specific checklist and time table to assure that all aspects of the formation of a Regional Police Department are effectively completed:

- b. advertise for, where and when necessary, and appoint consultants to assist in the implementation phase;
- c. undertake the process of selecting the Superintendent for the Regional Police Department;
- d. authorize municipal solicitor to commence work on a proposed Regional Police Department Agreement;
- e. appoint subcommittees, if necessary, to assist in the work of the committee and generally to do all things necessary to implement and prepare for the formal creation and establishment of a Regional Police Department for the participating municipalities.
- 6. The Borough of Charleroi authorizes cash expenditures not to exceed \$1,000.00 for the Phase III Implementation Study Committee. These cash expenditures shall be used for initial and continuing administrative expenses, including but not limited to any necessary actuarial studies that must be done of the Borough's Police Pension Fund. To the extent that an actuarial study may exceed \$1,000, the Borough of Charleroi Council hereby gives authority to exceed the amount of \$1,000 for the cost of an actuarial study to implement Regional Police Department. No other initial and continuing administrative expenses that exceed \$1,000 are hereby approved. Separate approval from Council must be obtained in order to expend any funds over and above \$1,000 for purposes other than a pension actuarial study. Each municipality shall contribute a like amount and all costs of the Study Committee shall be borne equally by the participating municipalities, with one exception. Speers Borough, not having a police department, is not required to obtain an actuarial study for a police pension fund. Speers Borough shall have no responsibility to contribute to the costs of actuarial studies that must be obtained by North Charleroi and Charleroi.
- 7. The Phase III Implementation Study Committee shall serve in a capacity of an advisory board only and the participating municipalities shall not be bound by the findings and recommendations of the committee. The committee shall have no authority to expend monies nor incur debt without the prior approval of the governing bodies of the participating municipalities, except as provided in Paragraph 6 above. Paragraph 6 permits the Implementation Study Committee to expend monies for the purposes of obtaining actuarial studies on pension funds and to expend no more than \$1,000 for initial and continuing administrative expenses. A complete accounting of initial and continuing administrative expenses shall be given to each participating borough and shall be shared with Council at their regularly scheduled public meetings and upon request of any councilman.
