Fair market value shall be established by identifying 3 comparable items in on-line sales or published sales and establishing a fair market price at a min. of 70% of the resale price using the combined average of the comparable items. WHEREAS, WCTCD has appointed Keystone Collections Group as the Tax Officer for EIT collection in the WCTCD; and

WHEREAS, 53 P.S. § 6924.514 provides that information gained by a tax officer, its agents, servants and or employees or by a tax collection committee as a result of any declarations, returns, investigations, hearings, or verifications shall be confidential tax information; and

WHEREAS, 53 P.S. § 6924.514 prohibits, except for official purposes or as provided by law, the Commonwealth, any political subdivision, any tax collection committee and or its members, any tax officer and or its agents, servants and or employees from divulging or making known confidential tax information, inter alia; and

WHEREAS, 53 P.S. § 6924.514 provides for criminal and civil penalties, including loss of employment, in the event of a violation of confidentiality requirements; and

WHEREAS, the WCTCC and the Tax Officer have requested the passage of this Resolution by the Council of the Borough of Charleroi to: 1) indicate the specific nature of information requested; 2) the administrative officer to whom the information is provided; and 3) to release the WCTCC and the Tax Officer from liability in connection with the release of such confidential information to the Borough's designated "Tax Liason."

NOW THEREFORE, BE IT RESOLVED:

- 1. The WCTCC and the Tax Officer are hereby authorized and directed to provide and or transmit all taxpayer information and records as permitted by the September Resolution of the WCTCD relating to earned income tax collection for Charleroi Borough for the period of January 1, 2014 to December 31, 2015.
- 2. The Council of the Borough of Charleroi hereby appoints Donn Henderson, Borough Manager, as the Borough's authorized representative to receive the above referenced tax records from the WCTCC and or the Tax Officer. Mr. Henderson shall use such records for "official purposes" as permitted by law.

- 3. The Council of the Borough of Charleroi hereby agrees to save harmless, indemnify and or absolve the WCTCC and the Tax Officer from and against any and all liability arising out of Mr. Henderson's receipt and or use of the confidential tax information.
- 4. A certified copy of this Resolution shall be provided to the WCTC and the Tax Officer, both of which may rely upon the Resolution and designation set forth herein on an ongoing basis until each receives written notice of a certified resolution to the contrary from the Borough of Charleroi.
