

ORDINANCE NO. 1049

BOROUGH OF CHARLEROI

AN ORDINANCE OF THE BOROUGH OF CHARLEROI, COUNTY OF WASHINGTON AND COMMONWEALTH OF PENNSYLVANIA, LEVYING TAXES FOR THE FISCAL YEAR ENDING DECEMBER 31, 2024 AT 9.85 MILLS

BE IT ORDAINED AND ENACTED by the Council of the Borough of Charleroi, County of Washington and Commonwealth of Pennsylvania, and IT IS HEREBY ORDAINED AND ENACTED by authority of the same:

THAT a tax be and the same is hereby levied on all real property within Charleroi Borough, Washington County, Pennsylvania subject to taxation for the fiscal year 2024 as follows:

Section 1. Tax Levy.

- A. General Borough Purposes for the purpose of providing sufficient revenue to meet the ordinary expenses of the Borough of Charleroi, and to discharge all other liabilities now due or that may become due and payable during the fiscal year beginning January 1, 2024 and ending December 31, 2024, a tax for general Borough purposes amounting to 9.85 mills upon each dollar of assessed valuation, or sum of \$0.985 on each one hundred dollars of assessed value, is hereby levied upon all real property and other objects of taxation within the Borough of Charleroi.
- B. All other municipal tax rates are to remain unchanged

Section 2. Discounts.

Pursuant to Section 10 of the "Local Tax Collection Law" a taxpayer subject to the payment of a tax levied by this Ordinance shall be entitled to a discount of two (2.00%) percent from the amount off such tax upon making payment of the whole of such tax within two (2) months after the date of the tax notice.

Section 3. Penalties.

A taxpayer subject to the payment of a tax levied by this Ordinance, who shall fail to make payment of such tax for four (4) months after the date of the tax notice, shall be charged a penalty of five (5.00%) percent, which penalty shall be added to the tax by the Tax Collector and shall be collected by the Tax Collector.

Section 4. Effective Date.

This Ordinance and tax levy shall take effect January 1, 2024


Section 5. Severability.

Any Ordinance or part of an Ordinance conflicting with the provisions of this ordinance are hereby repealed insofar as the same affects this Ordinance, provided, however, that this Ordinance shall in no way affect or repeal the provisions of any Ordinance imposing occupation, deed transfer, business privilege, mercantile, per capita, or other taxes imposed under the provisions of the Local Tax Enabling Act, as amended, all of which taxes shall continue in effect for the year 2024, as provided by law.




