Lorraine Smith, Debbie Devigne and Ernest Merritt spoke regarding the website creator Chris Kennedy.

Finance: Kristin Hopkins would like to have a Budget meeting for 2027 by July and review current YTD totals. President Paul Pivovarnik questioned the fuel cost and how much over budget we are. Borough Manager Joe Manning replied they are watching fuel costs very closely and cutting where they can.

Public Works: Thomas Santoro mentioned the Street Dept had 2 vehicles down. One was repaired and one needs to go to the shop. Kristin questioned purchasing new vehicles. Borough Manager Joe Manning stated they are looking to buy a new truck and a street sweeper with capital purchases they have in the budget. Kristin stated she would like to meet with finance.

Parks and Recreation: Jerry asked Borough Manager Joe Manning for updates. Joe stated that he has received phone calls and emails regarding the power being dropped at Woodland Park. There is a work order in place. Water has not been hooked up either.

Nancy Ellis stated Student Government Day was successful. Community Days are moving along, entertainment is scheduled and they are still looking for sponsors through 06/15/2026 and a grant for the 250th Anniversary.

Code, Fire EMS and Animal Control: Jerry Jericho read the Animal Control report, Code Enforcement Report, and EMS Report. Bobby Whiten gave the Fire Report and stated they are getting no donations and paying the part-time weekend personnel out of their own funds.

Personnel: Larry Celaschi stated they are trying to get health insurance rates. President Paul Pivovarnik asked if they should table Agenda item #9 and wait until June. Kristin Hopkins wants to look over the numbers first and asked for a recessed meeting to be held Tuesday, May 26, 2026 at 6pm.

Larry Celaschi gave a big thank you to the Charleroi Fire Department, police and EMS for their expertise, kindness and efforts with his mother.

Police: Mayor Ed Bryner stated there is a meeting Wednesday, May 20, 2026 at 6pm. Jerry Jericho read the police report.

Community Planning: Kristin Hopkins also stated how nice Student Government Day was and thanked Nancy Ellis for her help in planning. Kristin along with the Mon Valley Chamber of Commerce has sent questionnaires to the business owners in town asking how we can help them and the support they need. Streetscape is almost at completion and they are trying for more grants.


