

A RESOLUTION OF THE BOROUGH OF CHARLEROI, WASHINGTON COUNTY PENNSYLVANIA, AUTHORIZING THE CONVEYANCE OF TWO PARCELS OF BOROUGH REAL ESTATE TO THE CHARLEROI VOLUNTEER FIRE DEPARTMENT.

BE IT RESOLVED by the Council of the Borough of Charleroi, Washington County, Pennsylvania, as follows:

Real Estate described as a portion of Lot No. 467 and all of Lot No 469 in the plan of said Borough of Charleroi, fronting 41 feet on Fallowfield Avenue and extending back of uniform width 100 feet to an Alley and being more particularly described in Washington County, Pennsylvania Deed Book Volume 2274, Page 71 and further being Washington County Tax Parcel Identification Numbers 160-021-00-03-0027 and 160-021-00-03-0026-00 shall be conveyed to the Charleroi Volunteer Fire Department.

RESOLUTION No. 6

Whereas. The Commonwealth of Pennsylvania, Department of Transportation is the agency charged with granting permits to allow the placement of signs or banners within state right-of-ways; and

Whereas, the Department of Transportation requires the **Borough of Charleroi** to pass a resolution to authorize the placement of banners or signs and to set certain limits on said banners or signs; and

Whereas, the **Borough of Charleroi** wishes to allow banners or signs relative to national, regional or local functions, or charitable affairs

Now therefore be it resolved as follows:

That a banner measuring 3 (three) feet by 24 (twenty four) feet, and promoting Magic City Saturday and sponsored by Gerry Raymond Ford, and erected on June 15th and to be removed on June 29th 2026, will be placed over SR-88/McKean Avenue. And that no more than 20% of the message of said banner will relate to naming or advertising a commercial product, enterprise, business or company.

Be it further resolved that **Charleroi Borough** will assume full responsibility and accept full liability for erecting, maintaining and removing said banner. And, traffic control will be performed in accordance with most current Publication-203.
